ARTICLE II - DURATION

This Corporation shall exist in perpetuity as provided.

ARTICLE III - PURPOSE

This Corporation is organized to conduct any and all lawful business or act in any manner lawful under the laws of the United States.

ARTICLE IV - CAPITAL STOCK

The authorized capital stock of this Corporation shall consist of 7,500 Shares of Common Stock with \$1.00 par value per share.

The stock of the Corporation shall be issued for such consideration as may be determined by the Board of Directors.

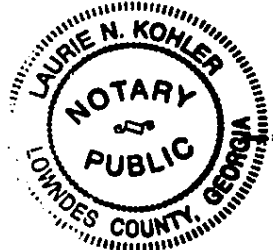




