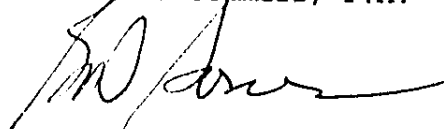

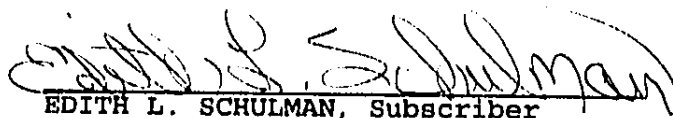
1. NAME. The name of the corporation is:

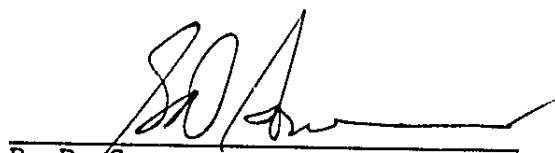
