ARTICLE I. NAME

The name of this corporation is BROADCAST NEWS SERVICE, INC.

ARTICLE II. DURATION

The period of duration of this corporation is perpetual.

ARTICLE III. PURPOSE


ARTICLE VIII. INDEMNIFICATION

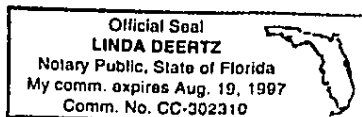

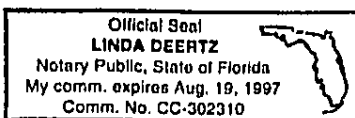
