ARTICLE I

NAME AND ADDRESS

The name of the corporation is PREVIEW COLLECTION, INC. The address of the corporation shall be 256 Giralda Avenue, Coral Gables, Florida 33134.

ARTICLE II

DURATION

This corporation shall have a perpetual existence commencing upon filing of the Articles of Incorporation with the Secretary of State.

ARTICLE III

PURPOSE
