# ARTICLES OF INCORPORATION

OF

PAT'S PLACE, INC.

#### ARTICLE 1

The name of this Corporation shall be PAT'S PLACE, INC.

### ARTICLE II

This Corporation shall exist in perpetuity.

#### ARTICLE III

The general nature of the business to be transacted by this Corporation is to: Manufacture, purchase or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, morchandise, real and personal property, foodstuffs, and services of every kind and description, except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telephone, telegraph, or cemetery company, a building and loan association, fraternal benefit society, state fair or exposition.

#### ARTICLE IV

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 1000 shares of common stock having a par value of One Dollar (\$1.00) per share.

#### ARTICLE V

The name of the registered agent is PATRICIA M. LOPEZ, and the street address of the initial registered agent is 3491 S. E. Martinique Trace, Stuart, FL 34997.

The Registered Agent hereby affirms that she is familiar with and accepts the duties and responsibilities of Registered Agent for said Corporation.

#### ARTICLE VI

This Corporation shall have one director initially, the name of the initial director is PATRICIA M. LOPEZ, and her address is 3491 S. E. Martinique Trace, Stuart, FL 34997. The number of directors may be increased or diminished from time to time by the By-Laws of the Corporation, but shall never be less than one director.

#### ARTICLE VIII

#### ARTICLE IX
