### ARTICLE III. CAPITAL STOCK

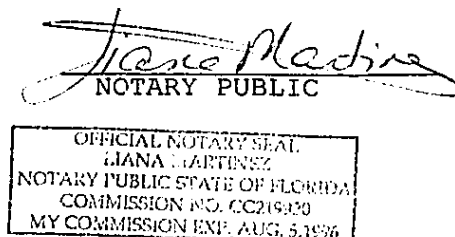
