The undersigned, acting as incorporator of JENNY E. FREEMAN, M.D., P.A., under the Florida Professional Service Corporation and Limited Liability Company Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation (the "Corporation") is JENNY E. FREEMAN, M.D., P.A.

ARTICLE II

ADDRESS

The street address and the mailing address of this Corporation shall be 3850 North 31st Terrace, Hollywood, Florida 33021.

ARTICLE III

DURATION AND COMMENCEMENT OF EXISTENCE

The duration of the Corporation shall be perpetual. The existence of the Corporation shall commence on the date of filing of these Articles of Incorporation with the Secretary of State of Florida.

ARTICLE IV

PURPOSE

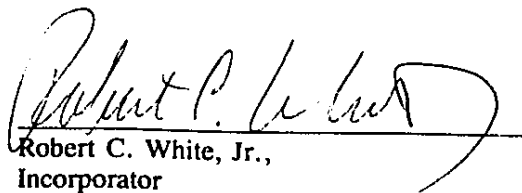

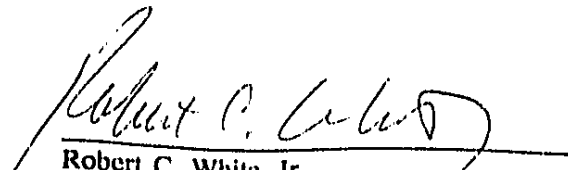
