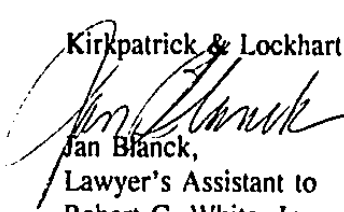

ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of Medical Imaging Investments, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation (the "Corporation") is Medical Imaging Investments, Inc.

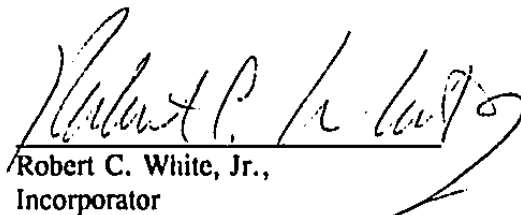

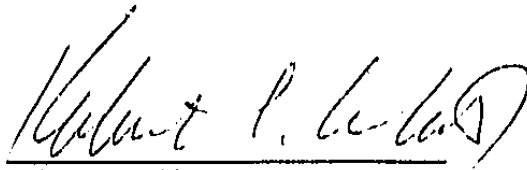
