#### ARTICLE

The name of this corporation shall be LAW OFFICES OF ROBERT DAVID MALOVE, P.A.

#### ARTICLE II

This corporation shall commence its perpetual existence upon the filing of these Articles of Incorporation with the Secretary of State of the State of Florida.

#### ARTICLE III

The general nature of the business to be transacted by this Corporation shall be and is to engage in every aspect and phase of the practice of law and any and all business permitted under Chapter 621 of the laws of the State of Florida. 
