ARTICLES OF INCORPORATION

OF

OCEANVIEW AQUARIUMS, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

This corporation is formed to act, without limitation, as a wholesale, retail or service business.
