ARTICLES OF INCORPORATION OF THE VALENTINE GROUP, INC.

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a personal services corporation under the Business Corporations Act and other laws of the State of Florida.

ARTICLE I

The name of the corporation is The Valentine Group, Inc.

ARTICLE II

The general nature of the business that will be transacted by the corporation is:

To engage in every phase, aspect, and activity of the business of rendering the same professional services to the public that a qualified business consultant is capable of rendering, and such professional services shall be rendered only through officers, employees, and agents who are duly or otherwise legally authorized to render such professional services within this state.
