The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of this corporation is SOUTHFORK PROPERTY DEVELOPERS, INC.

**ARTICLE II**

**DURATION**

This corporation shall have perpetual existence.

**ARTICLE III**

**PURPOSE**

The general nature of the business to be transacted by the corporation and its objects and powers shall be as follows:

A. To perform all legal purposes and engage in the transaction of any and all lawful business for which corporations may be incorporated under the law of the State of Florida.

B. To hold the title of real property and personal property as Trustee for the benefit of others; to serve as a Trustee; to enter into agreements with others to perform the services of a Trustee.

C. To buy, sell, lease, mortgage and manage real property and personal property, either as Trustee for the benefit of others or on its own account.




