**ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation for profit under the Florida General Corporation Act, does hereby adopt the following Article of Incorporation.

ARTICLE I

Name

The name of this corporation shall be WIPP, INC. , and its principal place of business shall be at 408 Winding Oak Lane, Longwood, FL 32750, but it may establish branch offices at any other points deemed advisable by its Board of Directors within the State of Florida.

ARTICLE II

Terms of Existence

This corporation shall commence on the date of the filing of these Article with the Secretary of State and shall have perpetual existence.

ARTICLE III

Nature of Business

This corporation may engage in any activity or business permitted under the laws of the United States and of this State.

ARTICLE IV

Capital Structure

The maximum number of stock that this corporation is authorized to have outstanding at any one time is 3000 shares of common stock, having a par value of \$1.00 per share.

ARTICLE V

Initial Registered Agent and Registered Office

The initial registered agent of the Corporation shall be Karl J Wipperfurth. The principal office and the registered office address of this Corporation is 408 Winding Oak Lane, Longwood, FL 32750.

ARTICLE VI

Board of Directors

There shall be a board of Directors for this Corporation which shall consist of not less than one (1). Except for the number constituting the Initial Board of Directors, the number of Directors shall be decided by the resolution of the Shareholders.

ARTICLE VII

Initial Board of Directors

The name and street address of each member of the initial Board of Directors of this Corporation, who subject to these Article of Incorporation and the laws of the State of Florida, shall hold office until the first annual meeting of the shareholders or until a

successor is elected and qualified, or until resignation, removal from office or death.

Any amendment to these Article of Incorporation so

made must be approved by a majority vote of the Shareholders of the Corporation.




