ARTICLES OF INCORPORATION

ARTICLE 1 - NAME

The name of this corporation is JIMSHARE, INC.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of conducting a wholesale tape brokerage business and transacting any or all lawful business.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 7500 shares of \$1,00 par value Common Stock, which shall be designated as "Common Shares."
