**ARTICLE I: NAME**

The name of the corporation is: Zimmy's Old Fashion Smoke House, Inc.

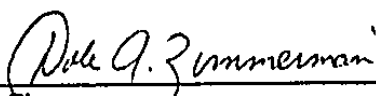
