ARTICLES OF INCORPORATION
OF
CROSSLAND ENTERPRISES, INC.
A FLORIDA CORPORATION

The undersigned, acting as Incorporator of CROSSLAND ENTERPRISES, INC., a Florida corporation (the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation is CROSSLAND ENTERPRISES, INC. and the street address of the initial principal office of the Corporation is 1000 PBIA, Suite 106, West Palm Beach, FL 33406.

ARTICLE II

PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE III

CAPITAL STOCK

The Corporation is authorized to issue 1,000 shares of no par value Common Stock.

ARTICLE IV

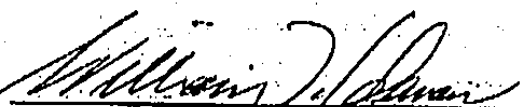
