TALLARS SEE PLOD The undersigned subscribes to these Articles of Incorporation, natural person, compatent to contract, does hereby form a corporation for profit under the laws of the State of Florida. Corporate existence shall begin upon acceptance of these Article's. This corporation is to be a Small Business Corporation as defined in Section 1244 Subdivision (c) (2) of the Luternal Revenue Code.

ARTICLE I. Name. The name of the corporation is Petra's Fashions, Inc.

ARTICLE 11. Term of Existence. This corporation shall have perpetual existence.

ARTICLE III. Nature of Busimess. This corporation may engage in any activity or business permitted under the laws of the United States and of this State.
