ARTICLE I - NAME

The name of the corporation is :

The corporation shall indemnify any officer or director, or any former officer or director, to the fullest extent permitted by law.

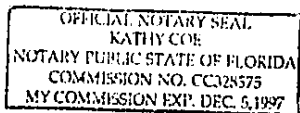
