The undersigned incorporators of VERTICAL MANIA, INC., hereby form a corporation for profit under the Florida General Corporation Act and other laws of the State of Florida.

1. NAME OF CORPORATION AND INITIAL ADDRESS: The name of this corporation shall be VERTICAL MANIA, INC. and the initial corporate address shall be 201 East 4th Street, Panama City, Florida 32401.

2. TERM OF EXISTENCE: This corporation shall exist perpetually unless dissolved according to law.

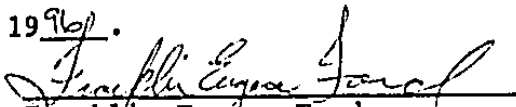

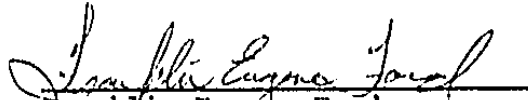
