ARTICLES OF INCORPORATION  
OF  
QuickNet, Inc.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is QuickNet, Inc.

ARTICLE TWO

The corporation will exist perpetually.

ARTICLE THREE

The general purposes for which this corporation is organized are:

1. To engage in the business of computer network implementation and as an Internet service provider.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act, or engage in any other lawful trade or business which can, in the opinion of the management of the corporation, be advantageously carried on in conjunction with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE FOUR

The aggregate number of shares which the corporation is authorized to issue is 100 shares. Such shares shall be of a single class, and shall have a par value of One Dollar (\$1.00) per share. No preferences, limitations, or relative rights, other than those provided by law, shall exist in respect of any of the shares of the corporation or any of the holders thereof.

ARTICLE FIVE

The street address of the initial principal and registered office of the corporation is 1750 A1A South, Suite E, St. Augustine, Florida 32084, and the name of its initial registered resident agent there is Roger C. Pitman.

ARTICLE SIX

The corporation shall have no initial board of directors, and all of the corporate powers shall be executed by, and the business and affairs of the corporation shall be managed under the direction of the stockholders, until such time as the stockholders shall vote to amend these Articles by majority vote.



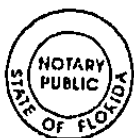


