ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. **Name.** The name of this corporation is Airway Collection Company.
2. **Duration.** The period of its duration is perpetual.

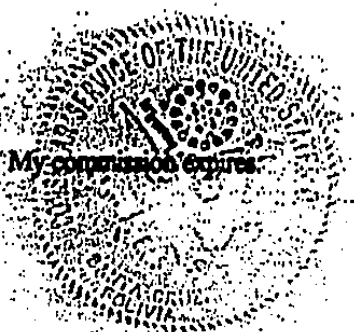


