ARTICLES OF INCORPORATION

OF

NAFTIS CONSTRUCTION CO., INC.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is NAFTIS CONSTRUCTION CO., INC.
