ARTICLES OF INCORPORATION

The undersigned does hereby subscribe to, acknowledge and file the following

Articles of Incorporation for the purpose of creating a corporation under the laws of
the State of Florida.

<u>I.</u>

The name of this corporation is:

IOMA, INC..

<u>II.</u>

This corporation is authorized for the purpose of transacting any and all lawful business permitted under the laws of Florida.

<u>HI.</u>

This corporation is authorized to issue one thousand (1,000) shares of one dollar (\$1.00) par value common stock, which shall be designated as "common shares". All of said stock shall be payable in cash, property (real of personal) or labor or services in lieu thereof at just valuation to be fixed by the Board of Directors.

<u>IV.</u>

Except by otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.

<u>V.</u>

This corporation shall commence its existence on the 18th day of March, 1996 and shall exist perpetually thereafter unless sooner dissolved according to law.

VI.

Every shareholder, upon the sale for cash of any new stocks of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchases his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the prices at which it is offered to others.
