THE UNDERSIGNED, acting as sole incorporator of Professional Internet Services, Inc., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation is Professional Internet Services, Inc.

ARTICLE II

Effective Date

The effective date of the corporation shall be March 18, 1996.

ARTICLE III

Shares

Initial Board of Directors


The corporation shall initially have one director and that director shall be Gretchen R.H. Vose, who shall manage the corporation.


