ARTICLES OF INCORPORATION

The undersigned incorporators to these Articles of Incorporation, natural persons over the age of eighteen years, competent to contract, and the majority of whom are citizens of the United States of America, hereby form a corporation for the purpose of operating as a mutual insurer under the taws of the State of Florida.

ARTICLE I

NAME
