of PRODECO ENTERPRISES, INC., a CORPORATION FOR PROFIT formed under the Florida General Corporation Act

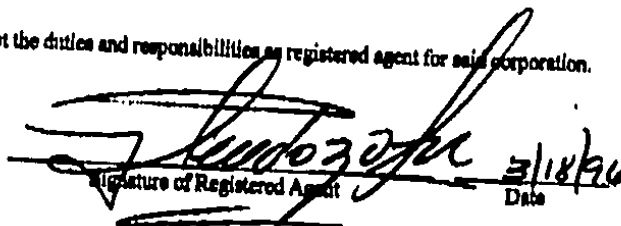
Article 1: Name of the Corporation: PRODECO ENTERPRISES, INC.

PAR VALUE \$0.01 (Information about PAR VALUE is not required but may be included).

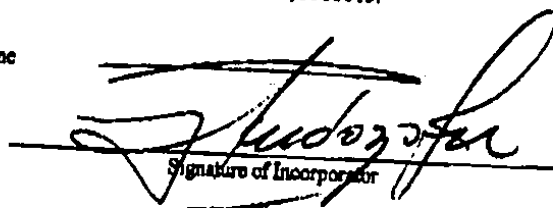
