The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I-NAME

The name of this Corporation is Interactive Tennis, Inc.

ARTICLE II-PRINCIPAL OFFICE

The street address of the initial principal place of business and mailing address of this Corporation are 1738 Moro Street, Jacksonville, Florida 32207.

ARTICLE III-NATURE OF BUSINESS

ARTICLE IV-CAPITAL STOCK
