#### ARTICLES OF INCORPORATION

OF

#### L.F.O. PRODUCTIONS, INC.

### ARTICLE I. NAME

The name of this corporation is L.F.O. PRODUCTIONS, INC.

### ARTICLE II. PURPOSE
