#### ARTICLES OF INCORPORATION

OF

#### AZTEK TECHNOLOGIES INCORPORATED

The undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

# ARTICLE I. Name of Corporation

The name of this Corporation shall be Aztek Technologies Incorporated.

#### ARTICLE II. Nature of Business

The general nature of the business and activities to be transacted and carried on by this Corporation are as follows:

- (a) Including but not limited to manufacturing of cable assemblies.


