**ARTICLES OF INCORPORATION

**ARTICLE I - NAME**

The name of this corporation is Royal Mortgage Lending Corporation.

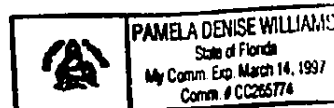
