ARTICLES OF INCORPORATION
OF
COASTAL GLASS & TRIM, INC.

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation shall be:

CAOSTAL GLASS & TRIM, INC.

and shall perform all business under the same name of:

COASTAL GLASS & TRIM, INC.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III. SHARES

This corporation is authorized to issue 100 shares of common stock with a par value of \$ 1.00, which shall be designated "common shares".

ARTICLE IV. PURPOSE

This corporation shall commence March 10, 1996 and shall have perpetual existence.

ARTICLE VI. PREEMPTIVE RIGHTS
