ARTICLE I - NAME

The name of this Corporation is FIRST COAST CAPITAL, INC. and its address is 200 S.E. First Street, Suite 701, Miami, FL 33131.

ARTICLE II - DURATION

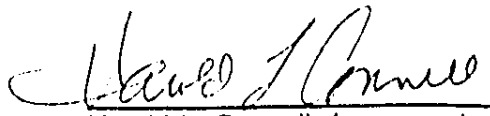
