ARTICLE I NAME

The name of this corporation is TJ CONTRACTORS, INCORPORATED.

ARTICLE II DURATION

This corporation shall exist perpetually.

ARTICLE III PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV CAPITAL STOCK

This corporation is authorized to issue Seven Thousand, Five Hundred (7,500) shares of One Dollar (\$1.00) par value common stock.
