ARTICLES OF INCORPORATION OF OCEAN IMAGE POST, INC.



The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

Article 1 - Name

The name of this corporation is OCEAN IMAGE POST, INC.

Article II - Duration

This corporation shall have perpetual existence.
