The undersigned incorporators hereby form a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I.

The name of this corporation is Shree, Inc.

ARTICLE II

The address of its principal office and the mailing address of the corporation is 1104 South Dixie Highway, Lake Worth, FL 33460.

ARTICLE III

The principal business of this corporation is the ownership and operation of a laundromat. This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE IV

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having \$1.00 par value per share.

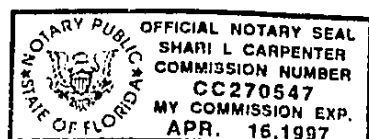
