ARTICLES OF INCORPORATION

OF FLECTRONIX, INC.

THE UNDERSIGNED SUBSCRIBERS to these Articles of Incorporation each a natural person competent to contract, hereby associate themselves together to form a corporation under the baws of the State of Fiorida.

ARTICLE I

The name of this corporation is: ELECTRONIX, INC.

ARTICLE II

The general nature of the business to be transacted by this corporation is:

- 1. All lawful purposes.
- 2.
