The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation:

**ARTICLE ONE  
NAME**

The name of the corporation shall be CONDEX INTERNATIONAL, INC.

**ARTICLE TWO  
TERM OF EXISTENCE**

The term of existence of the corporation shall be perpetual.

**ARTICLE THREE  
PURPOSE**

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act, including, but not limited to, the design, manufacturing, distribution, sale, and installation of composite steel deck.


#### **ARTICLE NINE PREEMPTIVE RIGHTS**
