To whom it may concern

On 7-31-2000 we were notified by the title company handling the sale of an office building owned by JRP Systems Inc. that the corporation had been dissolved. After talking to one mmilligan on 8-1-2000 and explaining the situation to him we were advised he would mail us the proper forms and we were to submit payment of \$615.00 along with a letter explaining the situation and the Dissolution of the corporation would be removed.

This letter serves as the explanation along with a copy of the original letter mailed and three pages of checking account Registers Reports. I apologize for the length of time it is taken to generate this final request by my personal travel had me out of the country for two weeks and the forms had not arrived before I left the country. I mention this only as time is of the essence as this matter is holding up the sale of an office building.

After mailing the check, letter and register report on or about 5/21/1998 no further action was taken by our company on the matter.

I have explained to mmilligan that during this time many of the checks written had to be deposited two and three times before the bank would cash them because Barnett Bank had been sold and we had considerable problems with the transfer of the checking account to the new bank including having to close and re-open the account two separate times between 5/1/98 and 6/30/98 at all times we had been assured by the personal at the bank no problems would occur. We later found out that our account had been transferred to a completely different bank at a new location and that checks written on Barnett Bank were actually being cashed by a different bank drawn against a temporary account untill proper paper work could be completed. The new bank refusing to open an account for us because the corporation had been dissolved further complicated this matter. I then indicated to the new bank that unless they opened the new account we would be unable to correct the dissolution, which finally convinced them to re-open the new account. After completing this entire process it was discovered that we would be unable to make deposits or keep our checking account at the branch that was located less than a mile from one of our offices and would require us to travel almost 15 miles to be able to make deposits. I then flew down to FL to meet with the bank officials to resolve this matter and ended up re-opening our original checking account with what is now the Bank of America after being told we could keep our checks and checking account number. Which ultimately proved to be wrong as we ended up having to open a new checking and savings account.

To summarize I believe that the check number 5106 mailed to cover two years was either not deposited because of some form of misunderstanding arising out of the original letter or that it was deposited and returned because of bank problems brought on because of the sale of Barnett Bank. In the event that correspondence at this point was required I can only assume it was sent to the original mailing address of the corporation not the new mailing address as shown on the Profit Corporation Annual report.
