**ARTICLES OF INCORPORATION
OF
W J D Enterprises, INC.**

The undersigned subscribers of these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation for profit under the laws of the State of Florida.

ARTICLE I

Name and Principal Office

The name of this corporation is W J D Enterprises, Inc. and it shall have as its principal address 27 Jasmine Drive, DeBary, Florida 32713. This shall also be the registered office address. The mailing address shall be the same.

ARTICLE II

Duration

The corporation is to exist perpetually.

ARTICLE III

Purpose

The corporation is organized for the purpose of the production of historical presentations, programs, CD Roms and videos as well as for any other activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

Capital Stock

The aggregate number of shares which the corporation has the authority to issue is 1,000 shares of common stock of a single class, with a par value of One

The capital stock shall be sold, signed, issued, and transferred in accordance with the By-Laws of this corporation.

ARTICLE V

Pre-emptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the prices at which is offered to others.
