Article I - Name and Address

The name of this corporation is CRYSTAL COMMUNICATIONS WORLDWIDE CORP. with its principal address as 411 S.W. 2nd Street, Boca Raton, FL 33432.

Article II - Duration

This corporation shall exist perpetually.

Article III - Purpose and Powers

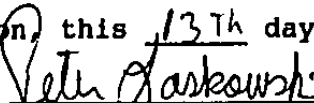

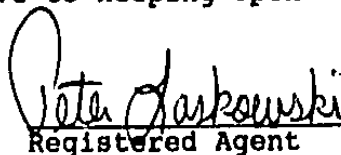
