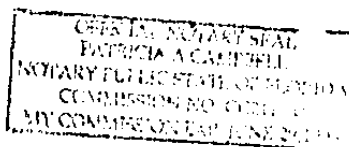

ARTICLE I: CORPORATE NAME

The name of this corporation is ISLAND PUBLISHING GROUP,
INC.

ARTICLE II: DURATION

The duration of this corporation shall be perpetual.
Corporate existence shall commence at the time of filing the
Articles of Incorporation with the Department of State.

ARTICLE II: PURPOSE

This corporation is organized for the purpose of transacting
any and all lawful business for which corporations may be
incorporated under the laws of Florida.

ARTICLE IV: CAPITAL STOCK

A. Number:

The corporation shall have the authority to issue 1000
shares of capital stock with a par value of .01 per
share.

ARTICLES OF INCORPORATION:

B. Initial Issue:

1000 shares of capital stock shall be issued initially at the par value of .01 per share.

C. Classes of Stock:

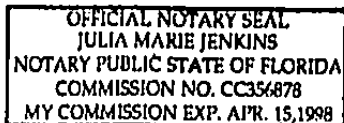
