ARTICLE I

NAME

The name of this Corporation is CALM LAKE TREES, INC. The address of the Corporation is 8620 Tarpon Springs Road, Odessa, FL 33556.

ARTICLE II

DURATION

This Corporation shall have perpetual existence.

ARTICLE III

NATURE OF BUSINESS

This Corporation is being formed for the following purposes:

To conduct any and all business activities permitted by the laws of the State of Florida.

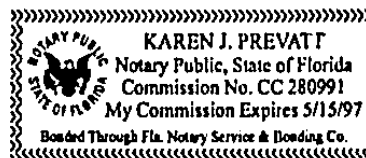
