ARTICLES OF INCORPORATION

OF

COAST ENGINEERING, INC. of Fla.

ARTICLE I

The name of this corporation is COAST ENGINEERING, INC. of Fla.

ARTICLE II

This corporation shall exist perpetually.

ARTICLE III

This corporation is organized for the purpose of transacting any or all lawful business activity for which corporations may be incorporated under Chapter 607 of the Florida Statutes.

ARTICLE IV

This corporation is authorized to issue 1000 shares of capital stock of no par value.

ARTICLE V

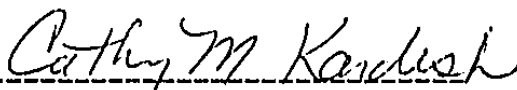
