

WE THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

- FIRST:** The name of the corporation is Udo Incorporated.
- SECOND:** The period of its duration is perpetual.
- THIRD:** The purpose(s) for which the corporation is organized are any and all lawful business activities for which corporations may be incorporated under chapter 607 of the Florida Statutes.
- FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is one thousand (1000) shares of common stock having a par value of ten dollars (\$10) each.
- FIFTH:** The corporation will not commence business until at least one thousand dollars (\$1000) have been received by it as consideration for the issuance of shares.
- SIXTH:** Cumulative voting of shares of stock is not authorized.
- SEVENTH:** Provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation are: NONE.
- EIGHTH:** Provisions for the regulation of the internal affairs of the corporation are: Governed by the by-laws of the corporation which shall be adopted by a majority of directors.
- NINTH:** The address of the initial registered office of the corporation is: 14904 Oldgate Place, Tampa, FL 33624 and the name if its initial registered agent at such address is Kimberly T. Jansen.
- TENTH:** Address of the principal place of business is 14904 Oldgate Place, Tampa, FL 33624.
- ELEVENTH:** The number of directors constituting the initial board of directors of the corporation is two (2), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:




