TO THE DEPARTMENT OF STATE OF THE STATE OF FLORIDA:

The undersigned, acting as incorporator of a corporation under the laws of the State of Florida, organized for the objects and purposes hereinafter stated, do make, sign, and file the following Articles of Incorporation:


