Before me, the undersigned authority authorized to take and administer oaths in the State and County aforesaid, personally appeared Gary W. Loveless, who on his oath stated that:

- 1. I am Gary W. Loveless, President of The Chambers Consultant Group of N. Florida, Inc. (hereafter the "Corporation") and I make this Affidavit with the authority of the Corporation and upon my personal knowledge.
- 2. I received from the Florida Department of States its Notice of Administrative Dissolution or Revocation of the Corporation in the fall of 1997.
  - 3. The receipt of this Notice shocked me for several reasons, namely:
- a. I had never received Notice of the need to file the Corporation's 1997 Corporation Annual Report, with payment of appropriate fees, and
- b. The corporation was only formed in March, 1996, and, in the course of trying to get the business going, I had not perceived that a year had transpired since the filing of the Articles of Incorporation. I assumed the notice would be sent to the Corporation's registered agent and, therefore, did not monitor the timing of this corporate need.
- c. The Corporation is engaged in business and I have every intention of retaining its existence.
- 4. I have tried to create a scenario by which the original Notice of Annual Report could have been mailed and delivered, but escaped my attention. It is possible that this occurred by the fact that the Corporation was sharing office space at the time in question and

using a receptionist not exclusively dedicated to the work of the Corporation. I have not been able to develop any precise knowledge as to what may have occurred with any attempted delivery (or, for that matter, whether delivery was in fact attempted) but I can say without question that I never knew of the delivery of the original notice of need to file the 1997 Corporation Annual Report and never received such notice.

5. Given the foregoing I, on behalf of the Corporation, respectfully request the Florida Department of State, Division of Corporations to review this matter and relieve the Corporation from payment of the reinstatement fees.
