ARTICLES OF INCORPORATION

In compliance with the requirements of Florida Statutes, Chapter 607, the undersigned, being a natural person, does hereby act as an incorporation in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I - Name

The name of this corporation ("corporation") is "ADVANCED AIR DUCT CLEANING, INC."

ARTICLE II - Principal Office

The principal office and mailing address of this corporation is 2848 St. Johns Bluff Road South, Jacksonville, Florida 32246.

ARTICLE III - Term of Existence

The Corporation shall have perpetual existence starting on the date these articles of incorporation are filed with the Florida Department of State.

ARTICLE IV - Capital Stock

The maximum number of shares this corporation shall have authority to issue shall be 10,000, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holder thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote.

ARTICLE V - Registered Office Registered Agent

The address of the initial registered office of this corporation is 2848 St. Johns Bluff Road South, Jacksonville, Florida 32246 and the name of the initial registered agent at that address is Shirley Dasher.

ARTICLE VI - Board of Directors

The business of the corporation shall be managed by its board of directors. The initial board of directors shall consist of three (3) members. Thereafter, the number of members may be either increased or decreased from time to time in the manner provided by the bylaws. The name and address of the initial members of this corporation are:

ARTICLE VIII - Restraint on Alienation of Shares

The shareholders of the corporation shall have the power to include in the bylaws, or by separate agreement adopted by a majority of the shareholders of the corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer or other disposition of any of the outstanding stock of the corporation by any of its shareholders, or in the event of the death of any of its shareholders. The manner and form, as well as the relevant terms, conditions, and details of the disposition, shall be determined by the shareholders of the corporation; provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice of the provisions unless the existence of the provisions is plainly noted on the certificate evidencing the ownership of such stock. No shareholder of the corporation may sell or transfer stock in the corporation except to another individual unless it has been approved at a shareholder meeting especially called for that purpose.

ARTICLE IX - Amendment

This corporation reserves the right to amend or repeal any provision contained in these articles of incorporation or any amendment thereto in the manner provided by law. Any right conferred upon the shareholders is subject to this reservation.
