ARTICLES OF INCORPORATION

We, the undersigned, subscribers to the Articles poi SECRETABY FORM a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be LAZ PRODUCTS, INC. Its principal place of business shall be 1432 Riverside Drive, Tarpon Springs, Florida 34689.
