## ARTICLES OF INCORPORATION

OF

GSB, INC.

The undersigned for the purpose of organizing and incorporating a corporation pursuant to the laws of the State of Florida, hereby makes, subscribes, acknowledges, and files these Articles of Incorporation.

#### ARTICLE I

# NAME OF THE CORPORATION

The name of this corporation shall be GSB, INC.

#### ARTICLE II

## PRINCIPAL OFFICE

The principal office of the corporation shall be at: 1000 Broward Road, # 503, Jacksonville, Florida 32218.

#### ARTICLE III

### DURATION OF CORPORATION

This corporation shall exist in perpetuity, unless sooner dissolved in a cordance with law; and its existence shall commence with the filing of these Articles of Incorporation by the Department of State.


