ARTICLES OF INCORPORATION OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name and Address

The name of the Corporation is Lalique Development, Inc. The principal office, if known, or the mailing address of the Corporation is 2375 Tamiami Trail North, Suite 208, Naples, Florida 33940.
